Fetal Monitoring Report

LEGEND

1. Type of dose. The dose displayed could originate from a fetal dosimeter, or it could be assigned from a whole body dose, if a fetal dosimeter is not present.
2. Estimated dose between conception and declaration is to be provided by the customer to be entered into the participant's records.
3. The previous rolling 12 months of exposure.
4. The pregnancy conception date, if provided to Landauer.
5. The date the pregnancy was declared to the facility.

GENERAL FACTS

- **Purpose:** The Fetal Monitoring Report displays all doses received by participants at the facility who have been pregnant any time within the past year. The report is intended to provide dose over the gestation period, with a rolling 12 months from the last month of pregnancy.
- This report is generated monthly or on demand.
- The report is generated and mailed to the primary reporting address listed at the account or subaccount level.

FREQUENTLY ASKED QUESTIONS

How is this different from the fetal addendum included with my Radiation Dosimetry Report?

This report shows only the fetal dose received by all participants in a given account/subaccount. Many State/Federal inspectors want to see a comprehensive report of all workers who were pregnant within the past year.

What is the difference between the “Assigned” and “Fetal” Dose Type?

The total fetal dose could come from the fetal dosimeter, the participant's dosimeter or the participant's EDE 2 calculation. Assigned dose shows the participant's assigned dose for reference.

Why is this worker on the Fetal Monitoring Report if they are no longer pregnant?

Any worker who has been pregnant within the past calendar year will appear on the report, regardless if they are currently pregnant or not.

How long will we receive this report?

If a 12 month period passes where there are no pregnant workers at your facility, then the report will no longer be generated. For example, if the last pregnancy at your facility was in June of 2013, then the report will generate until May of 2014.

Where does the dose in the “Account-Level Cumulative External Dose” column come from?

This is the total fetal dose summing all fetal doses received during the calendar year listed on the report. For example, if a participant receives a dose of 20 mrem in the first quarter of 2013, it would appear in this column until 2013 was no longer monitored on the report.

Can I adjust doses for a pregnant worker for months if she did not have a fetal dosimeter?

Yes. Fetal doses can be adjusted by communicating in writing (mail, fax, or email) to the Dosimetry Records Department.
